Storage

The vials of both opened and unopened must be stored at $2-8^{\circ}\text{C}$.

Stability

Unopened: Until the end of the indicated month of expiry

Opened: At least 30 days

Warnings and Precautions

- Each individual blood donation used for production of TruLab Albumin U/CSF was found to be non-reactive when tested with approved methods for HBsAg, anti-HIV 1+2 and anti-HCV. As there is no possibility to exclude definitely that products derived from human blood transmit infectious agents, it is recommended to handle the control with the same precautions used for patient specimens.
- Contains sodium azide (0.95 g/L) as preservative. Do not swallow! Avoid contact with skin and mucous membranes.
- TruLab Albumin U/CSF contains animal material. The controls should be handled as potentially infectious and with the same precautions used for patient specimens.
